

Contracts for the International Sale of Goods (CISG) Workshop

## Introduction:

As of 18 December 2015, the United Nations Commission on International Trade Law (UNCITRAL) reports that 84 States have adopted the United Nations Convention on Contracts for the International Sale of Goods (CISG).

The CISG is the uniform international sales law of countries that account for two-thirds of all world trade. Australia, New Zealand, Singapore, South Korea, Japan, Mongolia and China are all contracting states of the CISG. The applicability of the CISG in the Hong Kong SAR, however, remains unclear and is subject to debates.

In Hong Kong, lawyers and traders are increasingly involved in cases to which the CISG applies. Arbitrators have also been called upon to decide the applicability of the CISG to Hong Kong parties. What then do Hong Kong traders, lawyers and arbitrators need to know about the CISG?

## <u>Highlights:</u>

The workshop focuses on what common law lawyers, arbitrators and cross-border trading companies and merchants in Hong Kong need to know about the CISG. It will develop participants' understanding of the applicability of the CISG in Hong Kong and further substantiate their understanding of the principles and crucial differences between the CISG and English and Hong Kong law.

# <u>Speakers Profile:</u>

**Professor Michael Bridge** is the Cassel Professor of Commercial Law at the London School of Economics. He was an undergraduate and postgraduate student at LSE before starting his academic career. Before coming to the LSE in 2007, he held chairs in law at McGill University, the University of Nottingham and UCL, and was Dean of the Faculty of Laws at UCL. He has been a visiting professor at the Universities of Leeds, Malaya, Hong Kong, Melbourne, Sydney and Auckland and at Monash University. In 2013, he was elected a Fellow of the British Academy. In 2014 he was called as a Bencher of the Middle Temple. His books on *Sale of Goods* (Oxford University Press 3<sup>rd</sup> ed. 2014) and *International Sale of Goods* (3<sup>rd</sup> ed. Oxford University Press 2013) are considered leading texts in the field, along with *Personal Property Law* (Oxford University Press 4<sup>th</sup> ed. 2015). His many articles have appeared in such top-tiered journals as Current Legal Problems, Edinburgh Law Review, Law Quarterly Review, Modern Law Review, Uniform Law Review, I.C.L.Q., and the University of Hong Kong Law Review.

**Professor Larry DiMatteo** received his J.D. from the Cornell Law School; his LL.M. from Harvard Law School, and his Ph.D. in Business and Commercial Law from the University of Monash (Australia). In 2012, Professor DiMatteo served as a Fulbright Professor at the University of Sofia (Bulgaria) and was awarded the University of Florida's oldest and most prestigious award – "Teacher-Scholar of the Year." Also, in 2013 he was awarded the "Senior Scholar Award" for lifetime achievement by the Academy of Legal Studies in Business. Professor DiMatteo is the former Editor-in-Chief of the *American Business Law Journal*. He is the author or co-author of some 80 publications including 10 books and more than 40 law review articles. He has been a visiting professor at the Universities of Bocconi, Catania, Leicester, Münster, Sofia, Warsaw, and is currently a Visiting Fellow at City University of Hong Kong.
